Accounting Code

FASB Accounting Standards Codification

FASB ASC is designed to simplify user access to all *U.S. GAAP* by presenting the authoritative literature in an organized structure of about 90 topics. It also includes relevant portions of S.E.C. guidance. Browse by topic or search by keyword. A username and password is required and will be provided by instructors in classes where FASB is used. Students may also register for free Basic View access at https://asc.fasb.org/login.

Accounting Guides

GAAP Guide

GAAP analyzes accounting principles, applies them to various situations and industries, and cross-references the relevant FASB ASC section. The GAAP Library is within the CCH Internet Tax Research database under "Accounting and Auditing."

AICPA Accounting and Auditing Literature

In the AICPA core library are Accounting Trends & Techniques, AICPA Audit and Accounting Guides, and the AICPA Professional Standards. To access the AICPA audit and accounting material, new Regis students must first go to www.cpa2biz.com and choose Sign-in / New User / Non-AICPA Member to register and create a log-in. In a new window, log in to this site. Click on My Subscriptions at the top. Click on the tab My Online Publications. AICPA Core Library appears. Business Source Complete

The Business Source Complete database indexes many business and accounting journals, as well as providing Company Profiles, SWOT Analyses, and Industry Profiles. It has full-text articles from thousands of academic journals, trade publications and general news magazines. Other publication types include Country Reports, Market Research Reports, and monographs.

Lexis-Nexis Academic

This special database has full-text news sources, federal and state court decisions, law reviews, company financial "dossiers," business and trade news, and accounting.

Legal Trac

This is a good source for indexed articles from major law reviews, legal newspapers, and bar association journals.

Academic Search Premier

With a greater focus in the social sciences and humanities, the Academic Search Premier database is a good source for articles in areas related to public policy, ethical issues, and societal impacts.

Wall Street Journal

Full-text articles on business matters of the day since 1984.

Mergent Online

Here in detail are public companies' balance sheets, income statements, cash flow reports, ratios, competitors, officers and directors. Menu options under the Company Analysis List feature allow you to generate a company comparison report against a select group of peers or to create a multiple company report. Mergent also provides access to quarterly and annual SEC filings. Reports and filing statements can be downloaded as Word, PDF, HTML, or CSV files.

Standard & Poor's NetAdvantage

S&P NetAdvantage has insightful industry surveys, company profiles, annual reports, stock reports, financials, economic news, mutual fund coverage, and a weekly newsletter on the stock market.

Key Business Ratios

KBR provides industry ratios searchable by <u>SIC</u> and <u>NAICS</u> classification codes. The Key Business Ratios database provides industry overviews and analysis, too. Additional reference sources for industry ratios are in *print*: *RMA Annual Statement Studies* and *The Almanac of Business and Industrial Financial Ratios*.

Bizminer

This generates industry reports on financials for 5,000 lines of business. Its Competitive Market Analyzer examines 900 industries down to the zip code level. It also has Micro Market reports.
